WHEREAS, on 19 April 2024, Ms. Joyce Anne Escalona of Barangay Dulong Bayan, Bacoor City, Cavite (complainant) filed an administrative complaint against Punong Barangay Jade Emson Palma of the same barangay (respondent) for his alleged violation of Section 4 (a) and (b) of Republic Act No. 6713, Section 4 (the "Code of Conduct and Ethical Standards for Public Officials and Employees").

WHEREAS, the said matter was referred to the Committee on Ethics, Appointments and Government Re-organization and the Committee on Barangay Affairs for investigation committee hearing.

WHEREAS, the aforementioned committees of the Sangguniang Panlungsod conducted a number of committee hearings attended by the above-mentioned parties with regard the said allegation.

WHEREAS, on 27 June 2024, the last committee hearing that was conducted, the parties agreed to amicably settle their differences and they jointly moved for the dismissal of the said complaint.
