CITY RESOLUTION NO. 2024-545
Series of 2024

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN THE ENTIRE CITY OF BACOR, CAVITE DUE TO WIDESPREAD FLOODING BROUGHT ABOUT BY THE ENHANCED SOUTHWEST MONSOON DUE TO TROPICAL STORM "CARINA" AND AUTHORIZING THE CITY MAYOR TO DISBURSE THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND TO BE USED AS QUICK RESPONSE FUNDS FOR RELIEF AND REHABILITATION OPERATIONS AND OTHER INCIDENTAL EXPENSES RELATED THERETO.

WHEREAS, on 24 July 2024, the Bacoor City Disaster Risk Reduction and Management Council (BDRRMC) passed its Resolution No. 5, Series of 2024 entitled: "A RESOLUTION REQUESTING THE SANGGUNIANG PANLUNGSOD TO DECLARE THE EXISTENCE OF A STATE OF CALAMITY IN THE ENTIRE CITY OF BACOR DUE TO MASSIVE FLOODING BROUGHT ABOUT BY THE ONSLAUGHT OF THE ENHANCED SOUTHWEST MONSOON DUE TO TROPICAL STORM 'CARINA'."

WHEREAS, the continuous rains brought about by the enhanced southwest monsoon due to typhoon "CARINA" inundated large parts of the City of Bacoor affecting around 33,052 families residing in 43 of the 47 barangays in the city.

WHEREAS, there is also an undetermined number of residents in the remaining 4 barangays which were indirectly affected by flash floods.

WHEREAS, after deliberating on BDRRMC Resolution No. 5 and the various supporting documents presented before it by the City Social Welfare and Development Office (CSWDO), the Sangguniang Panlungsod unanimously voted in favor of declaring the entire City of Bacoor under a state of calamity.

Palabrica in special online session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the 5th Sangguniang Panlungsod of Bacoor, Province of Cavite, to declare the entire City of Bacoor under a **STATE OF CALAMITY** due to the extensive damages to property caused by the monsoon rains enhanced by typhoon "CARINA" and authorizing the City Mayor, Hon. Strike Revilla, to disburse **Ten Million Pesos (PhP10,000,000.00)** from the Disaster Risk Reduction and Management Fund to be used for relief and rehabilitation operations and other incidental expenses related thereto.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the BDRRM Office, the City Social Welfare and Development Office, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and all government offices concerned with copies of this resolution.
