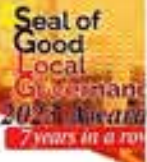

WHEREAS, Article II, Section 5 of the 1987 Philippine Constitution states that the maintenance of peace and order, the protection of life, liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessing of democracy.

WHEREAS, Section 16 of Republic Act 7140 or the Local Government Code of 1991 mandates all Local Government Units (LGUs) to ensure and maintain peace and order, within their respective areas of jurisdictions, among other concerns.

WHEREAS, as required by Section 4(f) of Republic Act No. 9080, also referred to as the "SK Reform Act 2004," the Sangguniang Kabataan (SK) Federation of Bacoor City is entrusted with encouraging youth participation in peace-building projects.

WHEREAS, the Bacoor City-PNP recognizes and accepts that only Law Enforcement Operations (LEO) are required in the area during the Stable Internal Peace and Security (SIPS) stage, which signifies the Bacoor City's normalization.

WHEREAS, to obtain Bacoor City SIPS status, Localized Peace Engagements (LPEs) are essential platforms for promoting dialogue, understanding, and collaboration amongst diverse stakeholders in tackling the underlying causes of conflict and cultivating a peaceful community.
