A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO PROCURE 12 UNITS OF VAN FOR CONVERSION INTO AN EMERGENCY RESPONSE VEHICLES WITH NECESSARY EQUIPMENT AND APPARATUSES WITH A TOTAL AMOUNT OF NINE MILLION NINE HUNDRED SIXTY THOUSAND PESOS (PHP9,960,000.00).
