**A RESOLUTION ADOPTING PROVINCIAL RESOLUTION NO. 3210-2024 DECLARING THE EXISTENCE OF A STATE OF CALAMITY OVER THE ENTIRE PROVINCE OF CAVITE DUE TO THE ONSLAUGHT OF TYPHOON CARINA AND AUTHORIZING THE 47 BARANGAYS OF THE CITY OF BACOR, CAVITE TO UTILIZE THE QUICK RESPONSE FUNDS OF THEIR RESPECTIVE BARANGAY DISASTER RISK REDUCTION AND MANAGEMENT FUNDS.**

**WHEREAS**, Provincial Resolution No. 3210-2024 was approved on July 24, 2024, due to the wide spread adverse impact of the Southwest Monsoon enhanced by Typhoon Carina on the whole Province of Cavite which was adopted by the City of Bacoor upon the recommendation of the Bacoor City Risk Reduction and Management Council (BDRRMC) through City Resolution No. 2024-545.

**WHEREAS**, the declaration of a state of calamity enables the local government as well as the barangays to access emergency funds swiftly and implement relief operations to aid the displaced residents residing in the 47 barangays in Bacoor City.

**WHEREAS**, different barangays experienced knee- high floods brought on by continuous heavy rains, which affected a great number of families within the city.

**WHEREAS**, to augment the need for food, emergency supplies, and other projects, the 30% Quick Response Fund of the Barangay Disaster Risk Reduction and Management Fund may be utilized to effectively respond to the affected families.
