A RESOLUTION CONCURRING IN THE ESTABLISHMENT OF END-OF-TRIP CYCLING FACILITIES IN SCHOOLS IN THE CITY OF BACOR, CAVITE THROUGH THE ACTIVE TRANSPORT PROJECT OF THE DEPARTMENT OF TRANSPORTATION AND AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT AMONG THE CITY GOVERNMENT OF BACOR, THE DEPARTMENT OF TRANSPORTATION, AND THE DEPARTMENT OF EDUCATION-CITY SCHOOLS DIVISION OF BACOR RELATIVE TO THE SAID PROJECT.

WHEREAS, on July 10, 2024 a letter from the Department of Transportation (DoTr) was sent to the Sangguniang Panlungsod of Bacoor City, Cavite requesting the City Council to pass a resolution concurring in the establishment of end-of-trip cycling facilities in schools in the City of Bacoor, Cavite through the Active Transport Project of the DoTr.

WHEREAS, the letter also stated the request of the Department of Education (DepEd) Region IV-A for the establishment of End-of-Trip Cycling Facilities (EOTCF) and identified 14 (fourteen) schools under the City Schools Division of Bacoor City (CSDO Bacoor) as valid locations of EOT Cycling Facilities.
