RESOLUTION ADOPTING REPUBLIC ACT NO. 11037 ("MASUSTANSIYANG PAGKAIN PARA SA KABATAANG PILIPINO ACT") TO COMBAT HUNGER AND UNDERNUTRITION AMONG FILIPINO CHILDREN AND APPROPRIATING FUNDS THEREFOR.

WHEREAS, Section 2 of Republic Act No. 11037 (also known as the "Masustansiyang Pagkain Para sa Kabataang Pilipino Act") provides that "the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. In recognition of the demonstrated relationship between food and nutrition, and the capacity of students to develop and learn, the State shall establish a comprehensive national feeding program that will address the problem of undernutrition among Filipino children."

WHEREAS, Section 7 of RA 11037 mandate local government to assist the national government agencies in the efficient and effective implementation of the said law and authorized LGUs to use a portion of the Special Education Fund (SEF) and/or their twenty percent (20%) development fund as provided for in Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", as amended to augment the appropriations available under the General Appropriations Act (GAA).

WHEREAS, promoting and protecting the physical, moral, spiritual, intellectual, and social well-being of the youth is among the top priorities of the City Government as evidenced by its consistent implementation of various programs that will ensure that all nutritionally compromised children residing within the City of Bacoor receive the proper nourishment, vitamins, and medical treatment as may be needed.
