**A RESOLUTION DIRECTING THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) TO CONDUCT A DRY RUN FOR SIX (6) MONTHS OF THE PROPOSED VISITATION INFORMATION SYSTEM (VIS) AT THE BACOOR CITY JAIL.**

**WHEREAS**, on 29<sup>th</sup> day of July 2024, the Bureau of Jail Management and Penology (BJMP) submitted a draft ordinance for the consideration of the Sangguniang Panlungsod that would have mandated the use of a so-called "Visitation Information System" (VIS) at the male and female dormitories of the Bacoor City Jail.

**WHEREAS**, the proposed ordinance was presented during a public hearing and it was discovered that cost of developing, using, and maintaining the VIS could not yet be determined.

**WHEREAS**, the members of the Sangguniang Panlungsod, like other government officials, are stewards of public funds and are expected by taxpayers to make wise and well-considered decisions before authorizing the release or disbursement of such funds. An informed decision cannot be made by the members of the City Council if there is no sufficient data related to the cost of developing, operating, and maintaining the proposed VIS.

**NOW THEREFORE**, upon motion of Hon. Alejandro F. Gutierrez, unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5<sup>th</sup> Sangguniang
