WHEREAS, on 26 July 2024, a complaint filed by Ms. Romalyn B. Cabrera (the "complainant") against Punong Barangay Michael Saquitan of Barangay Molino 2, Bacoor City, Cavite was referred by the Office of the City Mayor to the Sangguniang Panlungsod. The complaint stemmed from the respondent Saquitan's alleged use of an erroneous format in calling a hearing between the complainant and one Edenson Madlangakay, a resident of Barangay Queensrow West, regarding unpaid home rentals and his alleged failure to submit the minutes of the hearings conducted by the Lupon Tagapamayapa of his barangay pertaining to the Madlangakay's complaint.

WHEREAS, the Committee on Ethics, Appointments, and Government Reorganization reviewed the records of the said complaint and decided to dismiss the same on the ground that there is no sufficient evidence to hold the respondent liable for the allegations leveled against him by the complainant.
