**CITY RESOLUTION NO. 2024-600
Series of 2024**

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A PETITION FOR THE ISSUANCE OF CERTIFICATION OF EXEMPTION AND AUTHORIZATION FOR THE RELEASE OF PUBLIC FUNDS FOR THE VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES OF THE CITY GOVERNMENT OF BACOR DURING THE ELECTION PERIOD FOR THE 2025 NATIONAL AND LOCAL GOVERNMENT ELECTIONS.

WHEREAS, the 2025 National and Local Elections is scheduled to be held on 25 May 2025. As a consequence of the holding of the said polls, the Commission on Elections promulgated Resolution No. 10999 which provides in part that from 25 March 2025 up to 11 May 2025, local governments such as the City of Bacoor are prohibited from doing the following:

1. The appointment or hiring of new employees, creation of new positions, filing of new positions in a government office, agency, or instrumentality, whether national or local, including government-owned or controlled corporations, except upon prior authority of the Commission (Sec. 261 (g) (1), Omnibus Election Code);

2. The promotion or giving of salary increases, remuneration of privileges to any government official or employee, including those in government-owned or controlled corporations (Section 261 (g) (2), Omnibus Elections Code);

3. Release, disbursement, or expenditures of public funds, except those enumerated in Section 261 (v) of the Omnibus Elections Code; and

4. Construction of public works, delivery of materials for public works except for projects or work exempted in Section 261 (v) of the OEC, and issuance of treasury warrants or similar devices. (Section 261 (w), Omnibus Elections Code).

WHEREAS, if the City Government will comply with the above quoted provision of COMELEC Resolution No. 10999, the delivery of various vital public services will be discontinued and the promotion of the general welfare shall be adversely affected during the period aforementioned.

WHEREAS, to prevent this from happening, the City Mayor, Hon. Strike B. Revilla, formally requested the Sangguniang Panlungsod to pass a resolution authorizing him to sign a 'PETITION FOR THE ISSUANCE OF CERTIFICATION OF EXEMPTION AND AUTHORIZATION FOR THE RELEASE OF PUBLIC FUNDS FOR THE VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES OF THE CITY GOVERNMENT OF BACOR DURING THE ELECTION PERIOD FOR THE 2025 NATIONAL AND LOCAL GOVERNMENT ELECTIONS' (the "Petition"). A copy of the said Petition that the City Mayor intends to sign was likewise sent to the Sangguniang Panlungsod for its review and consideration.

WHEREAS, Section 16 of Republic Act No. 7160 (the "Local Government Code of 1991") empowered local governments to "exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants."

WHEREAS, the filing of the said Petition and the possible grant by the Honorable COMELEC of the various reliefs indicated therein will enable the City Government to exercise the various powers granted to it by law non furtherance of the general welfare.

NOW THEREFORE, upon motion of Hon. Rogelio M. Nolasco which was unanimously seconded by all the councilors present, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor,
