WHEREAS, the two methods of growth assessment in communities are being implemented thru Growth Monitoring and Promotion (GMP), the individual child regular growth monitoring for counseling and intervention and in the conduct of mass weighing referred to as Operation Timbang (OPT);

WHEREAS, the Operation Timbang Plus (OPT PLUS) is the annual mass weighing with the addition of the measurement of length or height of all preschool children aged 0-71 months old in a community to identify and locate families with malnourished preschool children;
