**A RESOLUTION ADOPTING THE ANTI-CRIMINALITY ACTION PLAN ENTITLED "OPLAN PANSIT-GAGAMBA" OR ANTI -WIRE PILFERAGE PLAN PREVIOUSLY APPROVED BY THE BACOOR CITY PEACE AND ORDER COUNCIL FOR THE YEAR 2014.**

**WHEREAS**, the Philippine National Police (PNP) submitted the Anti-Criminality Action Plan for the City of Bacoor entitled, "OPLAN PANSIT-GAGAMBA" or Anti-Wire Pilferage Plan previously approved by the City Peace and Order Council that provides the guidelines and procedures undertaken by the officers and members of the Bacoor City Police Station to exercise its police function in the implementation of Presidential Decree No. 1610 or Anti-Fencing Act of 1979, and Republic Act of 7832 or An Act Penalizing Pilferage of Electricity and theft of power transmission lines/materials rationalizing system losses by phasing out pilferage losses as a component thereof, and other purposes, and Republic Act No. 10515 or the Anti-Cable Television and Cable Internet Tapping Act of 2013, in order to effectively thwart the thievery of cable wires in the city.

**WHEREAS**, the proliferation of stolen electric power transmission lines and cable wires of telephones, internet and cable television are becoming more common within the City of Bacoor and combating it would require a comprehensive, multi-sectoral approach. The Bacoor City Police Station (BCPS) in coordination with different government agencies and non-government organizations shall intensify its operation against the group of people responsible for the stolen electric transmission lines and file necessary charges against them through the implementation of the said Anti-Criminality Action Plan.

**WHEREAS**, the anti-criminality action plan "Oplan Pansit-Gagamba" or Anti Wire Pilferage Plan was submitted to the Sangguniang Panlungsod for review and consideration.

**WHEREAS**, the Sangguniang Panlungsod deliberated on the said action plan and unanimously decided to approve the same.

**NOW THEREFORE**, upon motion of Hon. Bayani M. De Leon duly seconded by all the councilors present in regular session, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to adopt the Anti-Criminality Action Plan entitled "Oplan Pansit-Gagamba" or Anti Wire Pilferage Plan that was previously approved by the Bacoor City Peace and Order Council for the year 2014.
