**WHEREAS**, the Sangguniang Panlungsod received a letter signed by the Board of Directors of the General Parents-Teachers Association of Palico Elementary School located at Imus City, Cavite requesting the City of Bacoor, Cavite to "adopt" the said school considering that 79% of its students are allegedly residing at the latter.

**WHEREAS**, after conducting a committee hearing on the said request, the Sangguniang Panlungsod discovered that the Sanggunian has no power to grant the same.

**NOW THEREFORE**, upon motion of Hon. Rowena Bautista-Mendiola, unanimously seconded by all the councilors present in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to endorse the letter of the Board of Directors of the General Parents-Teachers Association of Palico Elementary School located at Imus City, Cavite requesting the City of Bacoor, Cavite to "adopt" the said school for appropriate action.

**RESOLVED THAT**, the DepEd and other government agencies/offices concerned shall be furnished with copies of this Resolution.

**RESOLVED LASTLY**, this Resolution shall become effective upon completion of its posting in at least (3) three conspicuous places in the City of Bacoor, Cavite and after it has been published once in a newspaper of general circulation within the Province of Cavite.
