A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE PROPOSED ESCROW AGREEMENT AMONG THE CITY GOVERNMENT OF BACOR, THE LAND REGISTRATION AUTHORITY (LRA) AND THE LAND BANK OF THE PHILIPPINES (LBP) REGARDING THE IMPLEMENTATION OF THE "LRA-BACOR TITLE AND TRANSACTION LINKAGE PROJECT".

WHEREAS, the Sangguniang Panlungsod received a letter from the City Mayor, Hon. Strike B. Revilla, requesting for the approval of a resolution authorizing him to sign a proposed *Escrow Agreement* among the City Government of Bacoor, the Land Registration Authority (LRA), and the Land Bank of the Philippines (LBP) in relation to the implementation of the **"LRA-Bacoor Title and Transaction Linkage Project"** (the "Project").

WHEREAS, after conducting a committee hearing on the said request, the Sangguniang Panlungsod discovered that the implementation of the Project shall be for highly beneficial to the people of the City of Bacoor and that provisions of the said *Escrow Agreement* are not contrary to law.

NOW THEREFORE, upon motion of Hon. Edwin G. Gawaran, unanimously seconded by all the councilors present in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Strike B. Revilla, to sign the proposed *Escrow Agreement* among the City Government of Bacoor, the Land Registration Authority (LRA), and the Land Bank of the Philippines (LBP) in relation to the implementation of the **"LRA-Bacoor Title and Transaction Linkage Project"**

RESOLVED THAT, the LRA and other government agencies/offices concerned shall be furnished with copies of this Resolution.

RESOLVED LASTLY, this Resolution shall become effective upon completion of its posting in at least (3) three conspicuous places in the City of Bacoor, Cavite and after it has been published once in a newspaper of general circulation within the Province of Cavite.
