A RESOLUTION REQUESTING THE BUREAU OF INTERNAL REVENUE (BIR), THE DEPARTMENT OF FINANCE (DOF), AND OTHER GOVERNMENT AGENCIES CONCERNED TO EXEMPT THE CITY OF BACOR FROM PAYING CAPITAL GAINS TAX AND OTHER TAXES IN RELATION TO VARIOUS PARCELS OF LAND OWNED BY THE CITY GOVERNMENT INTENDED FOR USE IN THE LATTER'S SOCIALIZED HOUSING PROGRAM FOR THE BENEFIT OF INFORMAL SETTLERS.

Palabrica, unanimously seconded by all the councilors present, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session assembled to request the Bureau of Internal Revenue (BIR), the Department of Finance (DOF), and other government agencies concerned to exempt the City of Bacoor from paying capital gains tax and other taxes in relation to various parcels of land owned by the city government intended for use in the latter's socialized housing program for the benefit of informal settlers.

RESOLVED LASTLY, to furnish the BIR, the DOF, the City Assessor, and all other government offices and agencies concerned with copies of this Resolution.
