Palabrica duly seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor, Cavite to extend the period for the issuance and application for the renewal of business permits as well as the payment of real property taxes until 31 January 2015.
