A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN BARANGAY NIOG 3, CITY OF BACOOD, CAVITE AND AUTHORIZING THE RELEASE OF TWO MILLION PESOS (PHP 2,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR RELIEF AND REHABILITATION OPERATIONS.

WHEREAS, a fire broke out in Barangay Niog 3, City of Bacoor, Cavite in the evening of 06 November 2014 resulting in massive damage to property and the displacement of around 225 families whose houses were destroyed.

WHEREAS, the City of Bacoor Disaster Risk Reduction and Management Council (CBDRPMC) passed Resolution No. 6, Series of 2014 dated 7 November 2014 requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangay Niog 3 and authorizing the release of Two Million Pesos (PhP 2,000,000.00) from the Disaster Risk Reduction and Management Fund.

WHEREAS, a copy of the said CBDRPMC Resolution No. 6-S-2014 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and approval together with reports from the City Social Welfare Development Office (CSWDO) confirming the extent of the damage caused by the said fire.

NOW THEREFORE, upon motion of Councilor Reynaldo D. Palabrica duly seconded by all the councilors present, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session assembled to declare the existence of a state of calamity in Barangay Niog 3 and authorizing the release of Two Million Pesos (PhP 2,000,000.00) from the Disaster Risk Reduction and Management Fund for financial assistance, relief goods and other incidental expenses in relation to the relief and rehabilitation operations.

RESOLVED LASTLY to furnish the CBDRPMC, the CSWDO, and other government offices concerned with copies of this Resolution.
