**A RESOLUTION AUTHORIZING THE CITY MAYOR AND THE CITY TREASURER TO OPEN A SPECIAL TRUST FUND FOR THE LOCAL POVERTY REDUCTION ACTION PLAN (LPRAP) PROJECT FOR THE RELEASE OF SEVEN MILLION PESOS (PHP7,000,000.00) FROM THE DEPARTMENT OF AGRICULTURE REGION IV-A IN FAVOR OF THE CITY OF BACOR, CAVITE.**

**WHEREAS**, on 11 August 2014, the Office of the City Mayor endorsed draft copies of Memoranda of Agreement referring to the financial assistance to be granted by the Department of Agriculture (DA) for the following project proposals of the City of Bacoor, to wit:

1. Rehabilitation and de-silting of Irrigation Canal of Molino Dam – PhP4,000,000.00;
2. Rehabilitation of existing Wharf at Barangay Sineguelasan – PhP 2,400,000.00; and
3. Non-motorized banca with fishing paraphernalia – PhP600,000.00.

**WHEREAS**, on 18 August 2014 the Sangguniang Panlungsod passed City Resolution No. CR 2014-54 entitled, "A Resolution Authorizing The City Mayor, Hon. Strike B. Revilla, To Sign And Enter Into Various Memoranda Of Agreement With The Department Of Agriculture On Behalf Of The City Government Of Bacoor Regarding The Financial Assistance Amounting To Seven Million Pesos (Php7,000,000.00) For The Rehabilitation Of And Desilting Of Irrigation Canal Of Molino Dam; Rehabilitation Of Existing Wharf At Barangay Sineguelasan, City Of Bacoor, And Non-Motorized Banca With Fishing Paraphernalia".

**WHEREAS**, in view of the foregoing, there is a need to authorize the City Mayor and the City Treasurer to open a special trust fund wherein the amount of Seven Million Pesos (PhP7,000,000.00) which will be released by the Department of Agriculture Region IV-A for the City Government of Bacoor shall accrue for the purpose of abovementioned project under Local Poverty Reduction Action Plan (LPRAP) project.

**NOW THEREFORE**, after careful deliberation, upon motion of Hon. Gaudencio P. Nolasco duly seconded by all the councilors present in regular session, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor and the City Treasurer to open a special trust fund wherein the financial assistance intended for LPRAP project of the City Government of Bacoor
