WHEREAS, the Sangguniang Bayan of Bacoor, Cavite issued Municipal Resolution No. 40-S-2011 approving the application for development permit of New Pacific Resources Management Inc. for a residential subdivision project to be known as "Arista Place Phase 2".

WHEREAS, on 19 November 2014, Mr. Carlo L. Peterson, Department Manager of New Pacific Resources Management Inc., requested City Mayor Strike B. Revilla and City Vice Mayor Catherine S. Evaristo in writing to authorize the change of "Arista Place Phase 2" to "**Soluna Phase 2**" to prevent confusion with potential buyers as a consequence of the use of the name "Arista Place" by another real estate developer.

WHEREAS, the said request was then forwarded by the City Mayor and the City Vice Mayor to the Sangguniang Panlungsod for appropriate action.

WHEREAS, this Body deliberated on the said request and found acceptable the reason behind the request of New Pacific Resources Management Inc.

NOW THEREFOR, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod in regular session assembled to approve the request of New Pacific Resources Management Inc. to change the name of its residential subdivision development project from "Arista Place Phase 2" to "**Soluna Phase 2**".
