A RESOLUTION ADOPTING THE 2015 INTEGRATED AREA COMMUNITY PUBLIC SAFETY PLAN AND ITS APPROPRIATION INCLUDED IN THE ANNUAL BUDGET OF THE CITY OF BACOOR AND AUTHORIZING THE CITY MAYOR TO UTILIZE THE CONFIDENTIAL/INTELLIGENCE FUND TO ADDRESS THE PROBLEMS OF PEACE AND ORDER IN THE CITY OF BACOOR.

WHEREAS, the City Peace and Order Council (CPOC) passed Resolution No. 02, Series of 2014 approving the 2015 Integrated Area Community Public Safety Plan and its appropriation included in the Annual Budget of the City Of Bacoor and authorizing the City Mayor to Utilize the Confidential/Intelligence Fund to address the problems of Peace And Order in the City of Bacoor;

WHEREAS, DILG Memorandum Circular No. 99-65 dated April 23, 1999, Policies and Guidelines relative to the Utilization of Funds for Intelligence or Confidential Purposes, provides that the allocation for peace and order concerns may be provided in the Annual Budget of an LGU. Provided, that peace and order is a priority investment area and the total annual amount appropriated for the intelligence or confidential undertakings shall not exceed thirty percent (30%) of the total annual amount allocated for peace and order efforts of the three percent (3%) of the total annual appropriations;

WHEREAS, DILG Memorandum Circular No. 99-65 dated April 23, 1999 also provided that the funds appropriated for intelligence and/or confidential activities shall be used for conduct of intelligence and/or confidential operations and shall be limited to the following (a) purchase of information; (b) payment of rewards; (c) rental and other incidental expenses relative to the maintenance of safe houses; and (d) purchase of supplies and ammunition provision of medical and food aid,
