A RESOLUTION ADOPTING RESOLUTION NO. 07 OF BACOOR DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (BDRRMC) DATED DECEMBER 18, 2014 ENTITLED, "A RESOLUTION REQUESTING THE SANGGUNIANG PANLUNGSOD TO AUTHORIZE THE DISBURSEMENT OF ADDITIONAL FUNDS TO ADDRESS THE POSSIBLE EFFECTS OF STRONG WINDS AND HEAVY RAINFALL BROUGHT ABOUT BY TYPHOON 'RUBY' ".

WHEREAS, on 18 December 2014, the Bacoor Disaster Risk Reduction and Management Council (BDRRMC) passed Resolution No. 07, Series of 2014, entitled, "A Resolution Requesting The Sangguniang Panlungsod To Authorize The Disbursement Of Additional Funds To Address The Possible Effects Of Strong Winds And Heavy Rainfall Brought About By Typhoon 'Ruby'".

WHEREAS, the above-mentioned resolution was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.

WHEREAS, based on the forecast track of Typhoon "RUBY" on the evening of December 5, 2014, the city will possibly experience strong winds brought about by heavy rainfall;

WHEREAS, pre-emptive evacuation have been done by various barangays living in coastal areas,

WHEREAS, according to City Social Welfare and Development Office, more than 6,000 individuals were staying in evacuation centers from December 7 to December 9;

WHEREAS, the Sangguniang Panlungsod deliberated on the said resolution and unanimously decided to approve the same.

NOW THEREFORE, upon motion of Hon. Bayani M. De Leon duly seconded by all the councilors present in special session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to adopt BDRRMC Resolution No. 07, Series of 2014 requesting the Sangguniang Panlungsod to authorize Acting City Mayor Hon. Catherine S. Evaristo, Bacoor DRRM Council, Acting Chairwoman, to disburse the additional amount of Five Hundred Thousand Pesos (PhP500,000.00) from the Disaster Risk Reduction and Management Fund to cover expenses incurred
