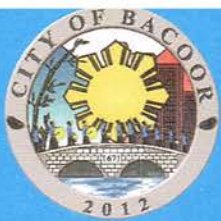

WHEREAS, in its continued support to the purposes of the said code, the City Environment and Natural Resources Office (CENRO) submitted the projects and activities /plans and programs of Bacoor City Government to combat climate change, to wit: (1) implementation of Ecological Solid Waste Management or RA 9003; (2) waste analysis and characterization study (WACS); (3) establishment of Materials Recovery Facility (MRF) per barangay or cluster of barangay; (4) Implementation of the Ordinance No. 14-S-2002; (5) Tree planting activity; (6) regular clean-up of river ways and waterways; (7) air quality; (8) eco caravan for public and private school, orientation on waste segregation and establishment of Materials Recovery Facility (MRF) per school; and (9) seminar/orientation on hospital waste management, to the Sangguniang Panlungsod for review and consideration.

WHEREAS, the Sangguniang Panlungsod deliberated on the said action plan and unanimously decided to approve the same.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica duly seconded by all the councilors present in regular session, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to adopt the Local Climate Change Action Plan of the City Government of Bacoor that was submitted by the City Environment and Natural Resources Office (CENRO).

RESOLVED LASTLY, to furnish the CENRO, the Office of the City Mayor, and other government offices concerned with copies of this ordinance.
