WHEREAS, due in part to the conversion of the former town of Bacoor, Cavite into a city by virtue of Republic Act No. 10160 and the various laws passed by Congress since 2008 affecting children, women, and other sectors of society – there is now a need to review the said codes and cause their revision.

WHEREAS, due to the sheer volume of the said codes, the number of laws and government regulations that must be considered in reviewing them, and the number of man hours that must be expended just to ensure that the said codes are properly revised – the Sangguniang Panlungsod intends to hire technical consultants that would assist it in reviewing and revising the said codes.

WHEREAS, the records of the Sangguniang Panlungsod shows that the erstwhile Sangguniang Bayan also hired technical consultants in drafting and formulating the said codes in 2008.

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Bacoor, Province of Cavite, upon motion of **Hon. Venus D. De Castro** unanimously seconded by the council, in regular session duly assembled, to authorize the City Vice Mayor, Hon. Catherine S. Evaristo, to hire technical consultants that will assist the Sangguniang Panlungsod in reviewing and revising the **Bacoor Children's Code (Municipal Ordinance No. 4-A-S-2008)** and the **Bacoor Gender and Development Code (Municipal Ordinance No. 4-B-S-2008)**.

RESOLVED MOREOVER, that the budget to be expended for the review and revision of the said codes shall be taken from the budget of the Sangguniang Panlungsod or of the Office of the City Vice Mayor.

RESOLVED FURTHER, that the various regulations embodied in Republic Act No. 9184 (also known as the "Government Procurement Act") and other pertinent government regulations shall be strictly observed in the hiring of the said technical consultants.

RESOLVED LASTLY, to furnish all government offices and agencies concerned with copies hereof.

UNANIMOUSLY APPROVED by the Sangguniang Panlungsod of the City of Bacoor, Province of Cavite this 14th day of July 2014.
