A RESOLUTION REQUESTING HIS EXCELLENCY, PRESIDENT BENIGNO SIMEON C. AQUINO III, THROUGH DEPARTMENT OF BUDGET MANAGEMENT SECRETARY FLORENCIO ABAD, TO ALLOCATE FUNDS FOR THE PROPOSED CONSTRUCTION OF A FLYOVER AT THE MOLINO-SALAWAG INTERSECTION ALONG DAANG HARI ROAD, CITY OF BACOR, CAVITE.

WHEREAS, the detrimental effect of vehicular traffic jams on the economy is now beyond doubt.

WHEREAS, the City of Bacoor - with the help of the Department of Public Works and Highways - have completed various projects to ease the flow of goods of vehicular traffic since 2008. While there has been much improvement on the traffic management situation in the City of Bacoor during the past six years, a lot still has to be done.

WHEREAS, one of the areas in the City of Bacoor that gets heavily congested with vehicular traffic during rush hours is the Zapote-Salawag Road and Daang Hari Road intersection, which connects the Bacoor to Dasmariñas City, Muntinlupa City, and Las Piñas City. Traffic sometimes is at a standstill in the said area due to heavy vehicular volume, the funnel-shaped design of the Zapote-Salawag Road, and the narrow width of the Daang Hari Road.

WHEREAS, consultations with the DPWH revealed that the only way to decongest the said area is through the construction of a flyover in the said intersection. Unfortunately, the limited resources of the city government prevent it from embarking in the said infrastructure project.

WHEREAS, in view of the foregoing, the City of Bacoor has no other recourse but to request His Excellency, Benigno Simeon C. Aquino III, through DBM Secretary Florencio Abad, to allocate funds for the construction of a flyover along the Zapote-Salawag Road and Daang Hari Road intersection in City of Bacoor, Cavite.
