A RESOLUTION ENDORSING ALL MATTERS RELATED TO VARIOUS COMPLAINTS REGARDING THE "SINGLE METERING PROJECT" OF THE CITY OF BACOOR TO THE CITY LEGAL OFFICE AND RECOMMENDING THE REMOVAL OF MS. MARIPESO ALFEREZ FROM THE BACOOR URBAN POOR HOUSING AND AFFAIRS COUNCIL.

WHEREAS, the Sangguniang Panlungsod have been deluged with complaints coming from members of various urban poor organizations regarding the alleged illegal activities of Ms. Maripeso Alferez, a Utility 1 employee of the General Services Unit under the Office of the City Mayor attached to the Bacoor Urban Poor Housing and Affairs Council, in relation to the "single metering project" of the City of Bacoor.

WHEREAS, official records show that the city government launched the said project to assist informal settlers in legally obtaining electric services.

WHEREAS, the City Council conducted a thorough investigation of the said matter and conducted numerous hearings attended by the complainants and by Ms. Alferez herself.

WHEREAS, during the said hearings, it was discovered that Ms. Alferez collected various sums from members of the said urban poor organizations totaling millions of pesos to be allegedly used for payment of the various requirements of the Manila Electric Company and of the city government in relation to the single metering project. Ms. Alferez publicly confirmed that she collected the said sums and that she deposited the same in a private bank account allegedly for safekeeping.

WHEREAS, it was also discovered that Ms. Alferez has no authority to collect the said sums much less keep the same.

WHEREAS, Ms. Alferez failed to return the said sums despite being given numerous opportunities to do so.

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod strongly recommends that the City Legal Office conduct its own
