A RESOLUTION ADOPTING RESOLUTION NO. 1-S-2014 OF CITY FISHERIES AQUATIC RESOURCES MANAGEMENT COUNCIL (CFARMC) REGARDING THE COASTAL USE ZONING PLAN OF BACOR BAY WITH APPROVED DELINEATION BY THE NATIONAL MAPPING RESOURCE INFORMATION AUTHORITY (NAMRIA).

WHEREAS, the City Fisheries Aquatic Resources Management Council (CFARMC) passed a resolution regarding the coastal use zoning plan of Bacoor Bay with approved delineation by the National Mapping Resource Information Authority (NAMRIA) pursuant to the 2008 writ of mandamus issued by the Supreme Court in "**Manila Bay Residents vs. MMDA, et. al.**". The said map shows that the municipal waters of the city has an area of 957.2472 hectares and its coastline is 5,778.4090 km. The same map also shows that the city's municipal waters is divided into 6 parts pursuant to the Comprehensive Sea Use Plan, to wit: (1) navigational zone; (2) aquaculture zone; (3) eco-tourism zone; (4) buffer zone; (5) fishing ground zone; and (6) mangrove area zone. It was also requested by the CFARMC that the mangrove area zone which covers an area of 40 hectares of the shoreline of Barangay Sineguelasan wherein more or less 132,000 trees were planted be declared as a protected zone area.

WHEREAS, the abovementioned resolution was submitted to the Sangguniang Panlungsod for review and consideration.

WHEREAS, the Sangguniang Panlungsod deliberated on the said resolution and unanimously decided to approve the same.

NOW THEREFORE, upon motion of Hon. Gaudencio P. Nolasco duly seconded by all the councilors present in regular session, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to adopt Resolution No. 1-S-2014 of City Fisheries Aquatic Resources Management Council (CFARMC) regarding the coastal use zoning plan of Bacoor Bay with approved delineation by the National Mapping Resource Information Authority (NAMRIA).
