A RESOLUTION ADOPTING CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 3, SERIES OF 2014, ENTITLED, "A RESOLUTION APPROVING THE REALIGNMENT OF PROJECTS FROM CONSTRUCTION OF REVILLA-TYPE MULTI-PURPOSE HALL/EVACUATION CENTER IN TALABA ELEMENTARY SCHOOL TO CONCRETING OF ROAD, CONSTRUCTION OF COVERED COURT, REPAIR AND IMPROVEMENT OF HEALTH CENTERS, CONSTRUCTION OF EYE CENTER, CONSTRUCTION AND REHABILITATION OF DRAINAGE, INSTALLATION OF STREETLIGHTS, CONSTRUCTION OF WAITING AREA AND SUPPLY AND INSTALLATION OF A/C UNITS FOR MPH/EVACUATION CENTER AND FROM WIDENING OF MIRANDA ST.
