**A RESOLUTION LIFTING THE MORATORIUM ON THE ESTABLISHMENT OF GASOLINE STATIONS WITHIN THE CITY OF BACOR, CAVITE.**

**WHEREAS**, the erstwhile Sangguniang Bayan of the then Municipality of Bacoor, Cavite passed Municipal Resolution No. 22 on 16 January 2012 imposing an indefinite moratorium on the establishment and opening of new gasoline stations all over the City of Bacoor.

**WHEREAS**, upon the request of various quarters, the Sangguniang Panlungsod decided to lift the said moratorium and allow the construction of new gasoline stations subject, however, to strict compliance with the various provisions of the Zoning Ordinance and policies of the City of Bacoor, the provisions of the National Building Code, and other relevant laws and government regulations.

**NOW THEREFORE**, upon motion of Hon. Reynaldo Fabian, unanimously seconded by the members of the Sangguniang Panlungsod of the City of Bacoor, Cavite, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** in regular session duly assembled to lift the moratorium on the establishment and operation of new gasoline stations within the City of Bacoor subject, however, to strict compliance with the various provisions of the Zoning Ordinance and policies of the City of Bacoor, the provisions of the National Building Code, and other relevant laws and government regulations.

**RESOLVED FURTHER**, that Municipal Resolution No. 22, Series of 2012 is hereby repealed.

**RESOLVED MOREOVER**, that this Resolution shall take effect immediately after it has been posted in at least three (3) conspicuous places within the City of Bacoor and after it has been published once in a newspaper of general circulation within the Province of Cavite.

**RESOLVED LASTLY**, to furnish the Business Permits and Licensing Office, the City Planning and Development Office, the City Building Official, the City Environment and Natural Resources Office, the City
