**RESOLUTION SUPPORTING THE ESTABLISHMENT AND OPERATION OF THE BIRTHING HOME OF THE CITY GOVERNMENT OF BACOR, INTO A MEMORANDUM OF AGREEMENT (MOA), WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), ST. DOMINIC MEDICAL CENTER, AND PARTNER HEALTH SPECIALIST SUCH AS AN OBSTETRICIAN AND A PAEDIATRICIAN, ON THE DELIVERY OF HEALTH SERVICES FOR AND IN THE CITY OF BACOR.**

**WHEREAS**, the Aquino Health Agenda (AHA) was launched to improve, streamline and scale up reform interventions espoused in the previous health reform agenda. The Universal Health Care or Kalusugan Pangkalahatan (KP) is the health sectors' implementation framework to implement the AHA and aims to provide adequate financial risk protection to families by achieving universal National Health Insurance Program coverage and expanding benefits; to ensure that families have sustainable access to modern health care facilities and services through a comprehensive facilities upgrading program; and to attain the health-related Millennium Development Goals (MDG) by focusing public health effort in areas where most families that are poor and have unmet need for health services are located.

**WHEREAS**, the National Government through the Department of Health provides funds for the enrolment of qualified indigent families to Philhealth.

**WHEREAS**, the identification of poor families for enrolment to Philhealth is a function of the Department of Social Welfare and Development.

**WHEREAS**, the National Health Insurance Program (NHIP) provides reimbursements for Primary Care Benefit Package, TB-DOTS and Maternity Care and Newborn Care Services to qualified indigent families in the City of Bacoor.

**WHEREAS**, there is a need for the City Government to establish and maintain the operation of the Birthing Home to ensure indigent families to have equal access to quality maternity and infant care, and to reduce infant deaths and improve maternal health.

**WHEREAS**, the Birthing Home shall be officially called the 24/7 City of Bacoor Lying-In and Eye Center and shall provide maternity services on prenatal and postnatal care, normal spontaneous delivery and care of the newborn.

**WHEREAS**, the 24/7 City of Bacoor Lying-In and Eye Center of City of Bacoor, Cavite should be accredited by Philhealth to the Maternity Care Package and Newborn Care Package programs to have access to reimbursements for the said health care packages.

**WHEREAS**, the 24/7 City of Bacoor Lying-In and Eye Center of City of Bacoor should operate with a license from the Department of Health to maintain quality standards in the provisions of health care.

**WHEREAS**, the City Government of Bacoor, in accordance to Department of Health's licensing requirements and Philhealth's accreditation requirements, shall establish linkages and partnerships with the Philhealth, Department of Health, St. Dominic Medical Center, and Health Specialists such as Obstetrician and Paediatrician, through Memorandum of Agreement/s and/or other instruments.

**NOW THEREFORE**, on motion of Councilor Roberto R. Javier duly seconded by all the councillors present in regular session, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to authorize the Honorable Mayor Strike B. Revilla to enter, for and in behalf of the City Government of Bacoor, into a Memorandum of Agreement (MOA), with the Philhealth, Department of Health, St. Dominic Medical Center Hospital, and Health Specialists such as Obstetrician and Paediatrician, on the delivery of health services for and in the City of Bacoor .
