CHITO M. CRUZ, FOR THE DEVELOPMENT OF A 1.5 HECTARE LOT OWNED BY THE CITY OF BACOR INTO A HOUSING PROJECT FOR THE BENEFIT OF THE POOR AND/OR LOW-INCOME FAMILIES IN THE CITY.

WHEREAS, the National Housing Authority (NHA) is the sole national government agency engaged in direct housing production mandated to meet the housing needs of low-income and marginal families and to focus its effort towards the housing needs of the lowest 30% of the urban population;

WHEREAS, pursuant to the Local Government Code of 1991 (LGC) and the Urban Development and Housing Act of 1992 (UDHA) local government units are mandated to take a principal role in the provision of housing services to its constituents;

WHEREAS, there is an immediate need to establish a resettlement project in the City of Bacoor, Cavite to accommodate families residing in various areas of this City previously identified as "danger areas" and are qualified for relocation and resettlement assistance under Republic Act 7279 (UDHA);

WHEREAS, the City has identified a 1.5 hectare property, more or less, as a resettlement site specifically located at Barangay Zapote I, City of Bacoor, Province of Cavite designated and identified said area as the resettlement site for families requiring relocation as approved by its Sangguniang Panlungsod;

WHEREAS, pursuant to R.A. 7279, the NHA and the City of Bacoor, agreed to pool their resources for the development of the Resettlement Project of the City of Bacoor, Cavite as a joint venture undertaking;
