A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF UNDERSTANDING, ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH KWANGSHIN UNIVERSITY, SOUTH KOREA FOR INTERCHANGE OF EDUCATION, ACADEMICS AND SOCIAL WELFARE FOR MUTUAL DEVELOPMENT OF BOTH PARTIES.

WHEREAS, in the said MOU, both parties will agree to set up a mutual cooperation for development of education and academic interchange; cooperate positively in personal interchange, cultural and social welfare exchanges; and cooperate positively for mutual organization development in mutual concerns.

WHEREAS, the Sangguniang Panlungsod deliberated the said memorandum and unanimously decided to approve the same.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica unanimously seconded by all the councilors present in regular session **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Strike B. Revilla, on behalf of the City Government of Bacoor to sign a Memorandum of Understanding with Kwangshin University, South Korea for interchange of education, academics, and social welfare for mutual development of both parties.
