A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN AND ENTER INTO VARIOUS MEMORANDA OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE ON BEHALF OF THE CITY GOVERNMENT OF BACOR REGARDING THE FINANCIAL ASSISTANCE AMOUNTING TO SEVEN MILLION PESOS (PHP7,000,000.00) FOR THE REHABILITATION OF AND DESILTING OF IRRIGATION CANAL OF MOLINO DAM; REHABILITATION OF EXISTING WHARF AT BARANGAY SINEGUELASAN, CITY OF BACOR, AND NON-MOTORIZED BANCA WITH FISHING PARAPHERNALIA.

WHEREAS, on 11 August 2014, the Office of the City Mayor endorsed draft copies of Memoranda of Agreement referring to the financial assistance to be granted by the Department of Agriculture (DA) for the following project proposals of the City of Bacoor, to wit:

1. Rehabilitation and de-silting of Irrigation Canal of Molino Dam – PhP4,000,000.00;
2. Rehabilitation of existing Wharf at Barangay Sineguelasan – PhP 2,400,000.00; and
3. Non-motorized banca with fishing paraphernalia – PhP600,000.00.

WHEREAS, the said financial assistance from the Department of Agriculture will help to enhance the agricultural productivity and uplift the economic conditions of the farmers and fisher folks in the City of Bacoor;

WHEREAS, the Department of Agriculture approved the request and drafted various Memoranda of Agreement pertaining to the grant of Seven Million Pesos (PhP7,000,000.00) to ensure the proper utilization of the financial assistance to be given by the latter;

NOW, THEREFORE, upon motion of Councilor Reynaldo D.
