A RESOLUTION REQUESTING SECRETARY FLORENCIO B. ABAD OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) FOR FUNDING ASSISTANCE IN THE AMOUNT OF ONE HUNDRED MILLION PESOS (PHP100,000,000.00) UNDER THE CALAMITY FUND FOR THE CONSTRUCTION OF REVETMENT ALONG BACOR RIVER AND THE AMOUNT OF FIFTY MILLION PESOS (PHP50,000,000.00) UNDER THE LOCAL GOVERNMENT SUPPORT FUND (LGSF) FOR THE CONCRETING OF ROADS, CONSTRUCTION AND REHABILITATION OF DRAINAGE CANAL IN THE CITY OF BACOR.

WHEREAS, on 14 August 2014, the Office of the City Mayor endorsed a letter requesting the Sangguniang Panlungsod to pass a resolution requesting Secretary Florencio B. Abad of the Department of Budget and Management (DBM) for funding assistance in the amount of One Hundred Million Pesos (PhP100,000,000.00) under the Calamity Fund for the construction of revetment along Bacoor River and the amount of Fifty Million Pesos (PhP50,000,000.00) under the Local Government Support Fund (LGSF) for: a) concreting of roads at Greenvalley, Brgys. Molino and San Nicolas- (PhP35,000,000.00); b) rehabilitation of drainage canal along Mambog Road - (PhP12,000,000.00); and c) construction of drainage canal at Progressive Village, Molino II (PhP3,000,000.00);

WHEREAS, recently, various retaining walls suffered more damages brought about by typhoon "Glenda" thereby posing a real and imminent threat to the properties and lives of the people residing near the river banks so there is a need to construct a revetment along Bacoor River.

WHEREAS, there is also a need to rehabilitate and construct drainage canals and the concreting of roads particularly at Greenvalley, San Nicolas; Barangay Mambog; and Progressive Village, Molino II to lessen the endless flooding problem in the city.

WHEREAS, the City Engineering Office submitted the Program of Works and Cost Estimates and related documents proving the

Abad of the Department of Budget and Management (DBM) for funding assistance in the amount of One Hundred Million Pesos (Php100,000,000.00) under the Calamity Fund for the construction of revetment along Bacoor River and the amount of Fifty Million Pesos (Php50,000,000.00) under the Local Government Support Fund (LGSF) for: a) concreting of roads at Greenvally, Brgys. Molino and San Nicolas- (Php35,000,000.00); b) rehabilitation of drainage canal along Mambog Road - (Php12,000,000.00); and c) construction of drainage canal at Progressive Village, Molino II (Php3,000,000.00).
