WHEREAS, the Sangguniang Panlungsod decided to approve the conditions stated in the Memorandum of Agreement after a careful deliberation and consideration of the provisions of the same which the council found to be advantageous to the City Government of Bacoor;

NOW THEREFORE, upon motion of Councilor Venus D. De Castro duly seconded by Hon. Roberto R. Javier in its 52nd regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor to authorize the City Mayor, Hon. Strike B. Revilla, to sign and enter into a Memorandum of Agreement with Smart Communications, Inc. on the proposed installation of telecommunication facilities like an outdoor cell site, an indoor DAS and the necessary facilities at Bacoor Government Center for and on behalf of the City Government of Bacoor.
