A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) IN THE IMPLEMENTATION OF DOLE'S EMERGENCY WAGE EMPLOYMENT TO AFFECTED FAMILIES OF TYPHOON GLENDA AND APPROPRIATE COUNTERPART FUNDS TO THE SAME.

WHEREAS, one of the major thrust of the City Government of Bacoor is the provision of employment and livelihood opportunities to the people of Bacoor City, Cavite;

WHEREAS, the City of Bacoor is one of the seriously affected by the recent typhoon GLENDA as evidenced by the town's report to the National Disaster Risk Reduction Council (NDRRC);

WHEREAS, the Department of Labor and Employment implements the Comprehensive Livelihood and Emergency Employment Programs (CLEEP) to help the affected workers displaced by the said calamity to have immediate source of income and help in the restoration of their lives and property;

WHEREAS, under the Comprehensive Livelihood and Emergency Employment Programs of DOLE the same is one of the integrated components of the same;

WHEREAS, DOLE Department Order 36-02, Series of 2002 No. III B Eligibility and Accreditation of Requirements prescribed the accreditation of co-partners whether from the private sector or the local government unit prior to release of fund assistance to the same and its project beneficiaries;

WHEREAS, the city government shall appropriate an equity in the form of cleaning materials to the 75 beneficiaries of the project;

NOW THEREFORE, on motion of Hon. Leandro A. De Leon duly seconded by Hon. Miguel N. Bautista in its 52nd regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor to authorize the City Mayor, Hon. Strike B.
