**WHEREAS**, the City Environment and Natural Resources Office (CENRO) and the Solid Waste Management Board of the City of Bacoor submitted a proposed Solid Waste Management Plan for the review and consideration of the Sangguniang Panlungsod.

**WHEREAS**, after conducting a series of public hearings on the said plan, the members of the Sangguniang Panlungsod unanimously decided to approve and ratify the proposed Solid Waste Management Plan.

**NOW THEREFORE**, upon motion of Hon. Reynaldo D. Palabrica, unanimously seconded by all the councilors present, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve and ratify the proposed ten-year Solid Waste Management Plan of the City of Bacoor.

**RESOLVED MOREOVER**, this Resolution shall take effect immediately after it has been published once in a local newspaper of general circulation and after it has been posted on the bulletin board at the entrance of the city hall and in two other conspicuous places within the City of Bacoor.

**RESOLVED LASTLY**, to furnish the Office of Congresswoman Lani Mercado-Revilla, the Office of the City Mayor, the City Environment and Natural Resources Office (CENRO), and other government offices concerned with copies of this Resolution.
