A RESOLUTION AUTHORIZING THE CITY MAYOR, HON STRIKE B. REVILLA, ON BEHALF OF THE CITY GOVERNMENT OF BACOOR, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES (LBP) REGARDING THE INSTALLATION OF AN AUTOMATED TELLER MACHINE (ATM) ON THE GROUND FLOOR OF BACOOR CITY HALL.

WHEREAS, the City Government of Bacoor is willing to allow the Land Bank of the Philippines (LBP) to use portion of space of 3 square meters, more or less, of the Bacoor City Hall located on the ground floor for the installation of an Automated Teller Machine (ATM) booth;

WHEREAS, the LBP is willing to install an offsite ATM unit at the premises of the Bacoor City Hall.

WHEREAS, a draft copy of Memorandum of Agreement was endorsed to the Sangguniang Panlungsod for review and consideration;

NOW THEREFORE, after careful deliberation, on motion of Councilor Venus D. De Castro unanimously seconded by all the Members of the Sangguniang Panlungsod in its regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor, Province of Cavite to authorize the City Mayor, Hon. Strike B. Revilla, on behalf of the City Government of Bacoor, to sign and enter into a Memorandum of Agreement with the Land Bank of the Philippines regarding the installation of an Automated Teller Machine (ATM) on the ground floor of Bacoor City Hall.
