WHEREAS, Addas Development Corporation offers to donate the above-mentioned lots to the City Government of Bacoor in order to construct the Mambog 3 Barangay Hall Building;

WHEREAS, a draft copy of Deed of Donation covering the said properties was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.
