WHEREAS, after conducting a series of public hearings on the said manual, the members of the Sangguniang Panlungsod unanimously decided to approve and ratify the proposed Manual on Civil Registration.

NOW THEREFORE, upon joint motion all the councilors present, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve and ratify the proposed Manual on Civil Registration of the City of Bacoor.

RESOLVED MOREOVER, this Resolution shall take effect immediately after it has been published once in a local newspaper of general circulation and after it has been posted on the bulletin board at the entrance of the city hall and in two other conspicuous places within the City of Bacoor.
