De Castro duly seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor, to authorize the City Mayor, Hon. Strike B. Revilla, to sign and enter into a Memorandum of Agreement, on behalf of the City Government of Bacoor with the Land Bank of the Philippines (LBP) for "Livelihood Loan Facility" to qualified city employees.
