A RESOLUTION REQUESTING HON. JUANITO VICTOR REMULLA, PROVINCIAL GOVERNOR, TO ALLOCATE FUNDS FROM THE OFFICE OF THE PROVINCIAL GOVERNOR AMOUNTING TO PHP 27,000,000.00 FOR VARIOUS INFRASTRUCTURE PROJECTS IN THE CITY OF BACOR, CAVITE.

WHEREAS, the Office of the City Mayor endorsed a letter to the Sangguniang Panlungsod to pass a resolution requesting the Office of the Governor for funding assistance of various infrastructure projects of the City Government of Bacoor as described below:

- (1) Barangay Zapote – PhP5,000,000.00;
- (2) Greenvalley Road, Barangays Mambog and Bayanan – PhP20,000,000.00; and
- (3) Barangay Queen's Row Central – PhP2,000,000.00.

WHEREAS, the said funds amounting to PhP27,000,000.00 to be granted to the City Government of Bacoor by the Office of the Provincial Governor would be of great help for the implementation of the former's priority programs and projects.

WHEREAS, due to the limited resources of the city government, it is necessary to request for financial assistance to allocate funds for infrastructure projects;

NOW, THEREFORE, after careful deliberation, on motion of Hon. Reynaldo D. Palabrica duly seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor, Province of Cavite, to request Hon. Juanito Victor Remulla, Provincial Governor, to allocate funds from the Office of the Provincial Governor amounting to PhP27,000,000.00 for various infrastructure projects in the City of Bacoor, Cavite.
