WHEREAS, on 01 September 2014, the City Development Council (CDC) of the City of Bacoor passed its Resolution No. 4, Series of 2014 approving the Annual Investment Plan (AIP) of the City of Bacoor, Province of Cavite for Calendar Year 2015.

WHEREAS, in compliance with the various pertinent provisions of RA 7160 and applicable government edicts and policies, the City Development Council formulated the Annual Investment Plan for Calendar Year 2015 of the City of Bacoor.

WHEREAS, the Sangguniang Panlungsod deliberated on CDC Resolution No. 4, Series of 2014 and on the proposed Annual Investment Plan for Calendar Year 2015 and unanimously voted to approve the same;

WHEREFORE, on motion of Hon. Reynaldo Palabrica unanimously seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to ratify the Annual Investment Plan for Calendar Year 2015 of the City of Bacoor.
