RESOLUTION REQUESTING AN APPROPRIATION IN THE AMOUNT OF ONE HUNDRED FIFTY MILLION PESOS (PHP150,000,000.00) FROM HIS EXCELLENCY BENIGNO SIMEON C. AQUINO III, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES THROUGH HON. FLORENCIO B. ABAD, SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), FOR THE CONCRETING OF ROADS IN GREENVALLEY SUBDIVISION, MAGDIWANG SUBDIVISION AND ESPERANZA SUBDIVISION ALL LOCATED IN THE CITY OF BACOR, PROVINCE OF CAVITE.

WHEREAS, the City Government of Bacoor have declared several subdivisions within its jurisdiction as "abandoned subdivisions" or "open communities", through City Resolutions upon the request of its residents due to several years of abandonment by its developers;

WHEREAS, Greenvalley Subdivision, Magdiwang Subdivision and Villa Esperanza Division were declared "abandoned subdivisions" or "an open community" by the City Government of Bacoor upon the request of its residents;

WHEREAS, due to the cessation of operations of its developers for many years past, said subdivisions were not maintained or developed and most of its roads were not concreted rendering them inaccessible to commuters and motorists;

WHEREAS, the City Government of Bacoor finds it necessary to develop the roads of said subdivisions for the benefit of its residents;

WHEREAS, the City Government of Bacoor is appealing for the appropriation of the necessary funds from the budget of the Office of the President represented by His Excellency, President Benigno Simeon C. Aquino III, for the concreting of roads in the abovementioned subdivisions to give convenience to the people living and to the general public;

NOW THEREFORE, on motion of Councilor Reynaldo D. Palabrica duly seconded by all the councillors present in regular session, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to respectfully request an appropriation in the amount of One Hundred Fifty Million Pesos (Php150M) from His Excellency Benigno Simeon C. Aquino III, President of the Republic of the Philippines thru Hon. Florencio B. Abad, Secretary of the Department of Budget and Management (DBM), for the concreting of roads in Greenvalley
