Revilla, To Sign A Deed Of Conditional Donation For And On Behalf The City Of Bacoor With Life Beyond Sanctuarium And Gardens, Inc. For The Establishment Of The "Bacoor City Crematorium", dated 17 February 2014.

**WHEREAS**, Mayor Strike B. Revilla signed a Deed of Conditional Donation on behalf of the city government with Life Beyond Sanctuarium and Gardens, Inc. dated 06 March 2014 pursuant to the authority granted to him under City Resolution No. 2014-055;

**WHEREAS**, the said donation pertains to the parties' agreement in the establishment of the "Bacoor City Crematorium".

**WHEREAS**, the Sangguniang Panlungsod reviewed the said Deed of Conditional Donation and unanimously decided to ratify the same.

**NOW THEREFORE**, upon motion of Hon. Reynaldo D. Palabrica unanimously seconded by all the councilors present in regular session **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to ratify the Deed of Conditional Donation dated 06 March 2014 between the City Government of Bacoor and the Life Beyond Sanctuarium and Gardens, Inc. regarding the establishment of the "Bacoor City Crematorium".
