**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO CAUSE THE FILING OF ALL APPROPRIATE LEGAL AND ADMINISTRATIVE ACTIONS AGAINST VARIOUS INDIVIDUALS AND JURIDICAL ENTITIES TO CAUSE THE RECOVERY OF THE OPERATION AND MANAGEMENT OF THE BACOR PUBLIC MARKET.**

**WHEREAS**, under Section 8 (3) (ix) of Republic Act No. 10160, the Mayor of the City of Bacoor has the power to "institute or cause to be instituted administrative or judicial proceedings for violation of ordinances in the collection of taxes, fees, and charges; for the recovery of funds and property; and cause the City to be defended against all suits to ensure that its interests, resources and rights shall be adequately protected";

**WHEREAS**, the City of Bacoor has been ordered by the Presiding Judge of Branch 19 of the Regional Trial Court of the City of Bacoor, Hon. Matias M. Garcia II, to turnover the operation and management of the Bacoor Public Market to the spouses Flaviana and Hernando Del Rosario in Civil Case No. BCV 2013-245;

**WHEREAS**, in order to protect the interests of the City of Bacoor, ensure the recovery of the operation of the Bacoor Public Market by the City,- there is a pressing need for the City of Bacoor to initiate the appropriate legal or administrative action against all individuals or juridical entities and cause the recovery of the operation and management of the Bacoor Public Market;

**NOW THEREFORE**, upon motion of Hon. Reynaldo D. Palabrica unanimously seconded by all the councilors present in regular session **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to authorize **Hon. Strike B. Revilla** to cause the filing of the appropriate legal or administrative action against all individuals or juridical entities and cause the recovery of the operation and management of the Bacoor Public Market.

**RESOLVED MOREOVER**, this Resolution shall take effect immediately after it has been published once in a local newspaper of general circulation and after it has been posted on the bulletin board at the entrance of the city hall and in two other conspicuous places within the City of Bacoor.

**RESOLVED LASTLY**, to furnish Branch 19 of the Regional Trial Court of the City of Bacoor, Cavite and other government offices concerned with copies of this resolution.
