A RESOLUTION REQUESTING THE ST. MICHAEL PARISH TO DONATE THE PARCEL OF LAND ON WHICH THE OLD NAWASA WATER TOWER IS LOCATED TO THE CITY OF BACOR FOR ITS POSSIBLE RESTORATION, PRESERVATION OR CONVERSION INTO A HISTORICAL LANDMARK.

WHEREAS, a water tower was constructed by the defunct National Water Services Administration (NAWASA) on a parcel of land owned by the St. Michael Parish near the historic St. Michael the Archangel Parish Church;

WHEREAS, the City of Bacoor intends to restore, preserve, or convert the said water into a historical landmark considering that many residents of the city have fond memories of the said tower while they were growing up;

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by all the councilors present in regular session **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to request the St. Michael Parish to donate the parcel of land on which the old NAWASA water tower is located to the City of Bacoor for its possible preservation, restoration, or conversion into a historical landmark with the use of public funds.

RESOLVED MOREOVER, this Resolution shall take effect immediately after it has been published once in a local newspaper of general circulation and after it has been posted on the bulletin board at the entrance of the city hall and in two other conspicuous places within the City of Bacoor.

RESOLVED LASTLY, to furnish St. Michael Parish, the Diocese of Imus, Cavite and all government offices concerned with copies of this resolution.


