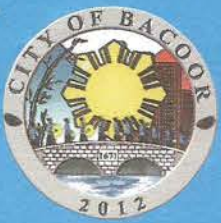

WHEREAS, DTI recognizes that its frontline services particularly in the area of business name registration will be more effectively implemented if brought closer to its clientele and that coordinative partnership with the private sector is forged towards this end;

WHEREAS, this endeavor can be done through the assistance of City of Bacoor, which has been established as one of the country's major hub in retailing, and upon which its clientele have reposed trust and confidence to their capability to serve;
