WHEREAS, much as the Sangguniang Panlungsod would like to assist the members of the said organizations, the law provides that it is the Department of Agrarian Reform (DAR) that primarily implements the Comprehensive Agrarian Reform Program (CARP). As such, the Sangguniang Panlungsod has decided to formally endorse their request for assistance to the DAR for appropriate action;

NOW THEREFORE, upon motion of Hon. Gaudencio P. Nolasco unanimously seconded by all the councilors present in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to formally endorse the request for assistance of the members of the Barangay Agrarian Reform Council (BARC) and the Nagkakaisang Samahang Magsasakang Bacoor Inc. Agrarian Reform Community to the DAR for appropriate action.

RESOLVED MOREOVER, this Resolution shall take effect immediately after it has been published once in a local newspaper of general circulation and after it has been posted on the bulletin board at the entrance of the city hall and in two other conspicuous places within the City of Bacoor.
