A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT SIGNED AND ENTERED INTO BY THE CITY GOVERNMENT OF BACOR AND BY THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)-REGIONAL OFFICE IV-A REGARDING THE "TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED (TUPAD) WORKERS" PROGRAM.

WHEREAS, the DOLE-Regional Office IV-A has been given the responsibility to provide emergency employment under the "*Tulong Panghanapbuhay Sa Ating Displaced/Disadvantaged (TUPAD) Workers*" Program to enable displaced workers due to economic crisis, natural calamities and armed conflicts to engage in short-term community work and to provide them with temporary employment for a period of ten (10) days;

WHEREAS, the DOLE Regional Office IV-A shall implement the abovementioned project in cooperation with the city government;

WHEREAS, in view of the foregoing, the Sangguniang Panlungsod passed City Resolution No. CR 2014-62 dated 18 August 2014 authorizing the City Mayor, Hon. B Strike B. Revilla, to enter into a Memorandum of Agreement with the Department of Labor and Employment (DOLE) in the implementation of DOLE's Emergency Wage Employment to affected families of typhoon Glenda and appropriate counterpart funds to the same.

WHEREAS, Mayor Strike B. Revilla signed a Memorandum of Agreement on behalf of the city government with the Department of Labor and Employment Regional Office IV-A dated 30 September 2014 and it was then submitted to the Office of the Sangguniang Panlungsod for ratification;

WHEREAS, the Sangguniang Panlungsod reviewed the said memorandum and unanimously decided to ratify the same.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica unanimously seconded by all the councilors present in regular session **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to ratify the Memorandum of Agreement signed and entered into by the City Government of Bacoor and by the Department of Labor and Employment (DOLE) Regional Office IV-A regarding the "*Tulong*
