A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO ENTER INTO AN MEMORANDUM OF CONFORMITY ON COMMUNAL TERMS THAT WOULD ALLOW GLOBE TELECOM INC. AND OTHER TELECOMMUNICATIONS COMPANIES TO LEASE CERTAIN PARCELS OF LAND OWNED BY THE CITY GOVERNMENT FOR THE CONSTRUCTION OF CELLSITES SUBJECT TO COMPLIANCE TO PERTINENT GOVERNMENT POLICIES AND REGULATIONS.

WHEREAS, the City of Bacoor own several parcels of land that are ideal for the construction of cellsites.

WHEREAS, the construction of various cell sites within the city would not only enhance the signal strength of the various telecommunications companies operating within the City of Bacoor but would also boost the productivity of cellular phone subscribers.

WHEREAS, each local government unit has the power to create its own sources of revenues and to levy taxes, fees, and charges subject to various provisions of the Local Government Code of 1991;

WHEREAS, Globe Telecoms Inc. submitted a draft Memorandum of Conformity on Communal Terms to the Office of the City Mayor wherein it offers to lease the following parcels of land owned by the city government for the construction of its cellsites, to wit:

RESOLVED FURTHER, that the authority granted herein is subject to the condition that Globe Telecoms Inc. and all other telecom companies that intends to lease any real property owned by the city government for the construction of a cellsite shall (a) ensure the health and safety of all individuals residing near or passing through the said sites, (b) submit a certification of safety on the installation of a cellsite to be issued by the Department of Health, or by any competent government agency, and (c) indicate in its proposed lease agreement or in any similar instrument that it shall strictly comply with all pertinent government regulations and that the city government or any of its officials or employees shall not be held liable by Globe Telecom Inc. or by any third party who may be injured or damaged during the construction or operation of the said cellsites.

RESOLVED LASTLY, to furnish Globe Telecom Inc. and other government agencies concerned with copies of this Resolution.
